Candidates who have passed the 5 year B.A. LL.B. (Hons.) Degree of the National University of Advanced Legal Studies (NUALS) or an examination recognized as equivalent thereto with a minimum of 55 % of the total marks in the aggregate [not less than 50 % in the case of SC/ST (declared eligible for reservation in the State of Kerala)] and who are interested in seeking admission to the One Year LL.M. Degree Course in the National University of Advanced Legal Studies, Kochi, are hereby directed to submit applications in the prescribed Proforma for Verification of Documents uploaded in the NUALS website (www.nuals.ac.in) to the undersigned not later than 4 p.m. on 5th August, 2015, by e-mail (admission@nuals.ac.in) along with self-attested scanned copies of the mark sheets, for admission against a few vacant seats under different quotas including Scheduled Caste/Scheduled Tribe Quota.

Candidates who have appeared for the Common Law Admission Test 2015 and whose names are included in the CLAT 2015 Rank list (PG) shall be given preference.

The seats shall be allotted in the order of merit from the CLAT 2015 (PG) Rank List and in the qualifying examination, subject to satisfying the eligibility criteria as prescribed by the CLAT/University. Those who fail to furnish copies of the relevant documents before the prescribed date and time will not be considered for allotment of seats for admission. Submission of duly filled in proforma or inclusion of name in the Provisional Selection List by itself will not confer any right to admission.
