NOTIFICATION

Sub: Payment of Academic fee for the year 2023-24 – Reg.

It is hereby notified the last date for remitting the tuition fee and other fees for the 2nd, 3rd, 4th and final year students of the 5 Year B.A. LL.B. (Hons.) Degree Course for the academic year 2023- 24, without fine is **15th July 2023** and with a fine of Rs.50/- (Rupees Fifty only) is till **22nd July 2023**. It will be further permitted to remit the fees on or before **30th July 2023**, along with a fine of Rs.100/- (Rupees One Hundred only) for each day of default, in addition to the fine of Rs.50/- (Rupees Fifty only). It is also hereby informed that the names of the students, who do not remit the fees by **30th July 2023**, will be removed from the rolls of the University. They will be permitted to attend the classes only after paying a re-admission fee of Rs.1,000/- (Rupees One Thousand only). In such cases, the benefit of attendance shall not be given to the students until they are re-admitted.

The payment can be made through the payment gateway provided in the NUALS Website through the HDFC Bank Payment Gateway. On making a payment, the students can generate a payment receipt with a unique Transaction Reference Number. This Number shall be noted and kept ready for the purpose of updation of fee payment details on the studentlogin in the AMS portal.

Students shall fill in the details required in the format provided in the AMS Portal. For the final submission of the details, the unique Receipt Number generated from the payment Gateway is mandatory. Those who are availing educational concessions from the Government and who are exempted from payment of Academic fees are required to use the **Code: EGRANTAC000 - - - (Roll No)** in place of the Receipt Number generated from the Payment Gateway. Students shall not make direct payments to the University Fee account without prior permission. In cases where prior permission is obtained, the student shall provide the transaction reference number for the updation of fee payment details.

The option for payment of Academic fees shall be open on the HDFC Payment gateway on the notified dates. The payment option will not be available beyond the last payment date and further requests for payment options will not be allowed, without written permission from the Academic department.

Students are required to make fee payments only through the HDFC payment gateway on the NUALS website. Those students availing educational loans or financial assistance from other sources shall write to academicfees@nuals.ac.in and obtain prior permission and collect the University's designated fee collection account details for making direct online payments.

General instructions to students for payment of Academic fees

1. Students are permitted to make payments only through the payment gateway.
2. Payment by other modes is allowed only under exceptional circumstances such as payments made by financing banks on behalf of students etc., in such cases prior written permission shall be obtained for such direct payments.
3. Request for permission for payments other than through the payment gateway shall be made to **academicfees@nuals.ac.in** stating reasons for obtaining prior permission and payment shall be made as advised by the academic section.
4. Students making payments other than through the payment portal shall ensure that the payment reference number which can be traceable from the NUALS bank statement or an identifiable receipt shall be provided to **academicfees@nuals.ac.in** and **accounts@nuals.ac.in**.
5. In case of payments received without a proper identification number or which cannot be traceable to any beneficiary shall be kept in a separate account. The amount will be adjusted against students only on the production of a proper receipt/identification number/evidence.
6. The payment gateway services shall be active only till the expiry of the notified days.
7. Payments beyond the notified days can be made only with the prior written permission of the academic section. Students shall ascertain the amount to be paid on the payment date including fines based on the demand raised from the academic section on the respective days.
