THREE YEAR EXECUTIVE LL.M. DEGREE PROGRAMME



The Executive LL.M. Degree Programme of NUALS is a regular course of THREE year duration in the credit and semester system consisting of six semesters. A candidate who is admitted to the Executive LL.M. Degree Programme can opt to pursue the Programme under any one of the subject groups offered by the University in that year. The three subject groups that are presently offered by the University are (1) International Trade Law, (2) Constitutional and Administrative Law and (3) Criminal Law. A student enrolled under a particular subject group will have to undergo compulsory, core and elective courses. Course wise Research Paper, Tutelage, Practical Sessions, Dissertation and Viva-Voce are the other components of the Executive LL.M. Degree Programme. For more details see the Regulations of the **NUALS Executive LL.M. Degree Programme.**

ELIGIBILITY

Candidates seeking admission to the Three-Year (Six Semester) Executive LL.M. Degree programme shall be required to have passed the Bachelor's Degree examination in Law of the National University of Advanced Legal Studies or any examination recognized as equivalent thereto by the University, has worked or is working as a professional / employee / advocate for a period of not less than five years since obtaining the Bachelor's Degree in Law and has obtained the necessary marks in the interview and / or written test as prescribed The reservation rules governing admission to LL.M. Programmes of NUALS shall be followed in making admissions.

ADMISSION PROCEDURE

Admission to the Executive LL.M. Degree Course shall be based on the performance in the Admission Test on Merit-cum-Preference basis. NUALS offers THREE year Executive LL.M. Programme in three distinct branches, i.e. (i) International Trade Law, (ii) Constitutional and Administrative Law and (iii) Criminal Law. The total intake for the LL.M.

Admission Test: 80 Marks Experience: 20 Marks (2 marks for each year over minimum experience for eligibility i.e., 5 years from the date of enrolment, but limited to a maximum marks-20)

SCHEME OF THE PROGRAM

A student for every branch in LL.M. shall, in the course of six semesters undergo instruction in three Foundation / Compulsory courses and at least seven Optional / Specialization courses offered in each semester leading to specialization in a discipline, apart from the Dissertation and Viva-Voce as per the notified scheme 1st, 2nd & 3rd semesters have one Compulsory Paper and one Elective Paper. 4th & 5th semesters consist of elective papers only. 6th semester is exclusively devoted for dissertation work.

The medium of instruction shall be English. The program is designed as to include, but not limited, to lecture classes, projects, written assignments and other library/ research/practical work/s.

In every semester 50% attendance is compulsory in lecture classes for completion of the course. In case of deficit, the course/s has/have to be repeated after paying prescribed fee if the same course/s offered in future semester/s for other batches of the same program or take another offered course/s after paying prescribed fee with permission of the University).
