If admitted, the candidates have to remit the prescribed fees by way of online transfer to the University account.

The total fee for the first year B.A. LL.B. (Hons.) Degree Course is Rs.1,96,870/-(Rupees One lakh Ninety six thousand Eight hundred and Seventy only) and a refundable Caution Deposit of Rs.10,000/- (Rupees Ten thousand only).

Hence, the total amount to be paid by the candidate for confirmation of admission to the B.A. LL.B. (Hons.) Degree Course is <u>Rs. 2,06,870/- (Rupees Two Lakh Six thousand eight seventy only</u>) including the Caution Deposit (Rs.1,96,870 + Rs.10,000). The candidates coming from institutions outside the State of Kerala is required to remit an additional amount of Rs.200/- towards Recognition Fee, i.e., such candidates have to remit a total amount of Rs. 2,07,070/- (Rupees Two Lakh Seven Thousand and Seventy only).
