## **SUBMISSION GUIDELINES**

Categories of submissions

- Articles - \*1500\*
- Case comments - \*700\*

The word limit is exclusive of footnotes and is flexible at the discretion of the Editorial Board.

1. All submissions must be made in the electronic form to [cclpnewsletter@nuals.ac.in](mailto:cclpnewsletter@nuals.ac.in) under the subject heading “Submission: The Competition law, e-Newsletter”.
2. The body of the mail shall contain details of the author (full name, semester & course (if a student), university/organization/freelancer(specify) and contact number).
3. Submissions must be made before **9<sup>th</sup> December 2020**
4. The submissions must be original works and should not have been published elsewhere.
5. All submissions are subject to a plagiarism check, if the work is found to be unoriginal the submission will be rejected. The Editorial Board reserves the right to reject any work during the review process if it is found to be unoriginal or not meeting the standards set by the editorial board.
6. Minimum plagiarism allowed 10%
7. Co-authorship of a maximum of 2 people is allowed.
8. Authors should give a declaration of originality along with the submitted works
9. CCLP reserves all the rights over the submitted works

#### **Formatting criteria.**

1. All submissions should be made in **.doc/.docx/.odt** format, Pdf submissions are not accepted.
2. The body of the manuscript must be according to the following specifications:
  - Times New Roman font
  - Font size 12
  - Line spacing 1.5
3. Submissions must follow the Bluebook (20th edition) style of citation. Footnotes must be in Times New Roman, font size 10 with single line spacing.
4. If drawings/cartoons/cartoon strips are added, it should be original
