It is hereby notified that Ph.D End Course Examination 2021 is scheduled to be held w.e.f 17th of May 2021.


All the candidates are requested to submit the application form for the registration of examination in the prescribed form along with the examination fee receipt. (**Mode of payment is Offline**). Application form attached.
