Applications in the prescribed form are invited for admission to the following Post Graduate Diploma Programmes for 2026

- (1) Post Graduate Diploma Programme in Medical Law & Ethics (PGDMLE)
- (2) Post Graduate Diploma Programme in Cyber Law (PGDCL)
- (3) Post Graduate Diploma Programme in Banking Law (PGDBL)

The maximum number of seats for each programme shall be fifty. The minimum qualification for admission to PGDMLE shall be a Bachelor's Degree in any subject from a recognised University. However, preference shall be given to candidates who possess a Bachelor's Degree in any system of Medicine, Dentistry, Nursing, Pharmacy, Hospital Administration or a Bachelor's Degree in Law recognized by NUALS. The minimum qualification for admission to PGDCL, PGDBL PGDIL and PGDELM shall be a Bachelor's Degree in any stream or a Bachelor's Degree in Law recognized by NUALS. Preference shall be given to those who possess a Degree in Law.

Application form can be downloaded from the University website (www.nuals.ac.in). A Demand Draft for Rs 500/- (Rs 250/- for SC/ST students) drawn in favour of "The Registrar, The National University of Advanced Legal Studies" on any scheduled bank payable at Ernakulam, towards Registration Fee shall also be submitted along with the filled-in application form.

The last date for receipt of filled in applications is **31-08-2026** Self-attested copies of certificates to prove age, qualifications and experience (10th Standard certificate, Degree Certificate and Experience certificate) shall be attached along with the application.

Each programme will be conducted only if a minimum of 20 candidates join the programme. Incomplete applications and applications without Registration fee will be summarily rejected.
